"Requiring persons to obtain a permit before making any excavation to put in and/or replace culvert pipe within a "Township road right-of-way"

The Board of Trustees of Mantua Township, Portage County, Ohio met at a regular session, on April 5th, 2012 at the Township Hall with the following members present:

Jason Carlton moved the adoption of the following resolution:

Whereas, pursuant to R.C. 5571.16, the Board desires to require any person, firm, or corporation to obtain a permit before making any excavation to put in and/or replace culvert pipe within a "Township road right-of-way"

Now, therefore, be it resolved by the Board of Trustees of Mantua Township, Portage County, Ohio, that:

Resolved, that the Board requires any person, firm, or corporation to obtain a permit before making any excavation to put in and/or replace a culvert in ALL township road public road right-of-ways, including installing any ditch culvert, within the jurisdiction of the Board.

and it is further

Resolved, that no person, firm, or, corporation shall make an excavation to put in and/or replace culvert pipe in such road right-of-way in violation of this resolution; except that, in case of an emergency requiring immediate action to protect the public health, safety, and welfare, an excavation may be made without first obtaining a permit, if such application is made at the earliest possible opportunity; and it is further

Resolved, that the formal actions of the board were taken in an open meeting and in full compliance with Ohio law.
